23 The Respondents Anthony Martini and Annette Martini suspects that most of the
24 Threats are from U.S. Government Employees.

11 The Respondents Anthony Martini and Annette Martini have a Legal Right to have
12 Ingrid Heather Abrash removed from the Respondents Case.

14 This Court has full information that the Respondent Anthony Martini is Disabled
15 and this Court and the "IJ" forced the Respondents to remain in Court for over 3
16 Hours until Ingrid Heather Abrash rewrote another false Charge which was the
17 same false charge that was already addressed in the past and proven to be false
18 which violates the Respondents Legal Rights to due process.

19
20 This Court and the "IJ" allowed a U.S. Government Attorney Ingrid Heather
21 Abrash to remain in Court and that amounts to persecution by the U.S.
22 Government Attorney Ingrid Heather Abrash since this Court at all times has full
23 knowledge that the Respondents Anthony Martini and Annette Martini filed a

1 The Respondents Typed the letter in Canada before they left but left the day blank

6 However, according to the recorded conversation Susan who is the Manager at the
