Dear High Commissioner Ms. Navi Pillay,

This is with respect to our letters dated May 28, 2010, July 2, 2010, August 23, 2010 and with respect to the three emergency messages that I Anthony Martini left on the OHCHR Phone number [REDACTED] Answering Machine on Friday, October 22, 2010.

I, Anthony Martini and I, Annette Martini demanded that the OHCHR assist us in leaving the United States of America and for the OHCHR to force the Country of [REDACTED] to immediately assist us with Travel Documents and Emergency Help to immediately leave the United States of America.

In our previous THREE COMPLAINTS to the OHCHR about Human Rights Abuse that was caused by the United States of America we the Plaintiffs Anthony Martini and Annette Martini supplied more than enough evidence to the OHCHR including United States Immigration Files, Orders, we also included Court Filings of our False Removal Proceedings and we also included three Writ of Certiorari in a booklet format that was filed to the United States Supreme Court.

All of our Legal Rights were denied here in the United States of America. All United Nations Laws pertaining to the “The United Nations Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment” were all violated against us by the United States of America.

It was the sole duty of the OHCHR to address our legitimate complaints but the OHCHR FAILED US.

The OHCHR the Organization that was supposed to protect Human Beings and Political Refugees ignored two honest Political Refugees and the OHCHR turned their backs on over 300,000 Legal Political Refugees that have been and still are facing FALSE REMOVAL PROCEEDINGS by the Host Country which is the United States of America.

In Our previous EMERGENCY LETTERS to the OHCHR we clearly indicated in writing to the OHCHR that our American Identifications the only two pieces of Identification we possess is our E.A.D. – Employment Authorization Card that was

issued by the United States Homeland Security and our Drivers License that was issued by the State of California would both expire in August 2010 and that we know that the United States of America will NOT renew our Identifications and especially if we do not have the money to pay for such a huge fee.

Our American Identifications have expired and the OHCHR did absolutely NOTHING to assist us the Plaintiffs Anthony Martini and Annette Martini.

In our previous Complaints we clearly warned the OHCHR that even if we succeeded in Having Our False Removal Proceedings Terminated the Corruption will continue and the Government Attorneys will APPEAL any Judge's Order for 100 Years and the OHCHR still ignored the warning signs and our EMERGENCY LETTERS, COMMUNICATIONS and COMPLAINTS!

The Presiding United States Immigration Judge, Judge Rodin Rooyani TERMINATED OUR FALSE REMOVAL PROCEEDINGS on Friday, August 13, 2010 and placed extreme classified documents in her final order that was never mentioned in Court Proceedings since 2006 to the Current Date and furthermore we the Defendants in that case have never supplied this Classified information to the United States Immigration Court or to any United States Government Attorney.

This Classified information will have us murdered here in the United States of America. We gave this classified information to Former President George W. Bush and to Former U.S. Attorney General John Ashcroft. This information was classified and sealed under the Bush Administration. I Anthony Martini was advised by the U.S. State Department from 2002 to 2009 that this classified information would remain classified and sealed forever.

However under the Obama Administration and direct orders from President Obama all our classified information was released to all of our enemies in Canada and also to all corrupt United States Government Employees which will have us murdered and assassinated here in the United States of America because the Host Country, the United States of America decided to retaliate and persecute us because we dared sue The United States of America and it's Agencies for Gross Human Rights Abuse, False Removal Proceedings, Persecution, Torture, Attempted Murder by

placing us in False Removal Proceedings to have us murdered by our previous Country which is Canada.

The same United States Government Attorney Ingrid Heather Abrash that we sued in United States District Court refused to step down and two United States Immigration Judges denied our Motions to have this Corrupt United States Government Attorney that we sued removed from our files and our Case.

The United States Government Attorney Ingrid Heather Abrash filed a Falsified Notice of Appeal on or about September 13, 2010 to the United States B.I.A. – Board of Immigration Appeals.

When a United States Immigration Judge, dismisses False Removal Proceedings or Removal Proceedings, then the United States MUST by LAW give relief to the Respondents or to the Defendants.

Our False Removal Proceedings was terminated twice by two different United States Immigration Judges. The first one was by United States Immigration Judge William Joseph Martin Jr., on Monday, March 31, 2008 and our second False Removal Proceedings was terminated on Friday, August 13, 2010 by United States Immigration Judge Rodin Rooyani.

United States Government Attorney Ingrid Abrash filed an appeal on both occasions to abuse her authority because we sued Ingrid Abrash and others for their lies and the False Removal Proceedings and for attempted murder.

At all times our presence and our Case here in the United States has been pending. Eight Years and 3 Months later our case is still pending and our case will be forever pending.

In our previous letters to the OHCHR we clearly advised the OHCHR in details what would happened and we also told the OHCHR that our Landlord where we were renting an Apartment would NOT renew our lease in July 2010, that came true and our lease was not renewed forcing us to move after almost four years where we later advised that the United States Government was behind this evil plot of which we have proof of.

In our previous letters and complaints to the OHCHR we clearly indicated that the United States of America Corrupt Government Employees are stopping a disabled man from making any money whatsoever by the United States attacking my websites where I sell Advertising and where I sell my Brand Name Silk Neckties of "ANTHONY MARTINI" which is Registered Trade Mark. All of the warnings to the OHCHR became true.

The Corrupt United States Government has contacted our previous Landlord in California so he will NOT renew our lease.

On July 13, 2010 we moved to a new one bedroom Apartment and now the Landlord as of Wednesday, October 27, 2010 has started taking Legal Action to have us evicted at our new address because the Corrupt United States Government Employees contacted the new owner which means we have already been served with Legal documents to evict us out of our apartment and put us on the streets where the United States of America Government wants us so we can be murdered.

Furthermore, the United States have attacked us and attacked all of our websites continuously on a daily basis and we have all the log sheets of the United States Department of Justice and the United States Homeland Security going on all of our websites every single day stopping a disabled man from making any money whatsoever on the Internet.

I also have log sheets of the U.S. Homeland Security attacking all my websites putting viruses on my websites and hacking into my websites to stop all my advertisers from ever advertising with us again stopping a disabled man from making an honest living on the Internet.

I Anthony Martini was advised on a recorded conversation that the reason why my banks closed all my accounts and cancelled all my credit cards was because the banks received a phone call from U.S. Homeland Security ordering the Banks to cancel all my credit cards and closing my bank accounts without ever going to Court.

I also have emails sent to my hosting company from a United States Government Employee by the name of Megan Berry Oshiro who started our False Removal

Proceedings who ordered our Hosting Company to shut down our personal website of AnnetteMartini.Org which has received eleven billion visits worldwide because we also sued Megan Berry Oshiro in Federal Courts.

On Monday, October 18, 2010 I, Anthony Martini and I, Annette Martini were forced to go to the Social Services or Welfare Office in California.

I, Anthony Martini ran out of Heart Medications and we had no food and no money.

The State of California refused Emergency Financial Help to a disabled man and also refused to give us any Food Stamps or assist us with the rent.

On Tuesday, October 19, 2010, I, Anthony Martini contacted “LEGAL AID” in the state of California to assist me with the future Eviction and also with Social Services or Welfare. Legal Aid is supposed to assist individuals who have no money. I, Anthony Martini and I, Annette Martini were REFUSED any Legal Assistance from the Government Control Agency.

The reason that was given to me Anthony Martini was that the Legal Aid called the United States Homeland Security and the Legal Aid was told that our case is PENDING.

The Social Services or Welfare also contacted the United States Homeland Security and the Social Services or Welfare was told that our case is still pending.

We have sent Faxes to the White House, to President Barack H. Obama, to United States Attorney General Eric H. Holder Jr., from the United States Department of Justice, to Secretary of United States State Department – Secretary of State Hilary R. Clinton, to the Secretary of United States Homeland Security Janet Napolitano and we have only received NOTHING BUT SILENCE and with each Faxed Letter we get persecuted even more.

It is the sole Duty of the OHCHR and the United Nations to assist Political Refugees and when the OHCHR or the United Nations have knowledge and information of a “STATE” violating Political Refugees Rights or any citizens

rights then the OHCHR and the UNITED NATIONS must take Legal Actions against that Country or the STATE or the Host Country.

To this date NOTHING has been done by the OHCHR or by the United Nations.

The OHCHR and the United Nations are looking the other way and allowing the "STATE" the United States of America to PERSECUTE and TORTURE Legal Immigrants and Legal Political Refugees.

President Barack H. Obama ordered the United States Homeland Security and the United States Department of Justice to place over 300,000 Legal Immigrants and Legal Political Refugees in FALSE REMOVAL PROCEEDINGS in January 2010.

On Tuesday, October 26, 2010, I found out that the United States of America are further endangering the Lives of Legal Immigrants and Legal Political Refugees by placing their A# Alien Number their names, addresses and children's names on the B.I.A. Board of Immigration Appeals website, at the USCIS.GOV websites, on the Justice.Gov website and thousands of Attorneys are riding off the department of Justice Websites placing all Court Documents of Legal Immigrants and Political Refugees on the Attorneys Websites.

This information is endangering the lives of all Political Refugees here in the United States of America that fled their Country of Origin to Escape Torture and Political Persecution.

Any enemy of a Political Refugee has immediate access to this Private Information. If a Political Refugee had a Legal Name Change that information of the New Name and the Old Name is available for the Public to see.

The websites also discloses addresses of Legal Political Refugees and Legal Immigrants for the entire world to download.

I, Anthony Martini suspect that the Obama Administration recently ordered the Department of Justice to make all Legal Immigrants and Political Refugees Private Information and court Proceedings available to the Public which will definitely have millions of Legal Immigrants and Political Refugees MURDERED here in the United States of America.

Furthermore, I went numerous times since 2006 to the current date to the United States of America Government Websites including the USCIS.GOV, JUSTICE.GOV and other Federal Agencies and that information was not available so this to my personal knowledge was done very recently.

A Political Refugee or a Legal Immigrant here in the United States thinks and expects that the HOST COUNTRY or the STATE will protect them from further persecution and Torture and keep their files safe from the Public and keep their A# Alien Number safe from the Public, but instead the HOST COUNTRY or THE STATE being the United States of America is exposing all Legal Immigrants and ALL Political Refugees by further endangering the LIVES of all Legal Immigrants and Legal Political Refugees by the United States of America placing all of the Legal Immigrants and Political Refugees Classified Information all over the Internet.

The United States of America Supreme Court does NOT post all Appeals they receive on the websites. The U.S. Supreme Court only mentions the Case Number and if it was Docketed and if it was heard or denied.

The OHCHR and the United Nations should immediately without any delay FORCE the United States of America and all of its Federal Agencies to IMMEDIATELY remove all court information and all names and A#'s from its websites and protect Political Refugees and Legal Immigrants.

We have demanded Travel Documents from all United States Federal Agencies and from Two Presidents of the United States of America and from three Secretary of States and from Five Attorney Generals and from three Secretary of United States Homeland Security from 2002 to the Current Date.

All Federal Agencies of the United States of America have totally ignored our emergency request for Travel Documents and have kept myself, Anthony Martini and myself, Annette Martini as PRISONERS of the United States of America because we cannot travel anywhere we want.

We are NOT allowed to leave the United States of America, however the United States of America placed us in False Removal Proceedings since 2006.

The United States of America DOES NOT want us, Anthony Martini and Annette Martini here in the United States of America and WE DO NOT WANT TO REMAIN HERE IN THE UNITED STATES OF AMERICA a Country that violated all of our Legal Rights and a Country that Persecuted and Tortured us since 2002 to the current date.

We want a DIVORCE from the United States of America and we want the OHCHR and the United Nations to immediately assist us by forcing the Country of [REDACTED] to immediately assist us in leaving the United States of America and Immediately permanently move us to the Country of [REDACTED] as we have asked before but we have been ignored by the High Commissioner of the OHCHR.

We demand that the OHCHR and the UNITED NATIONS immediately without any delay assist us with EMERGENCY FINANCIAL HELP and also with EMERGENCY TRAVEL DOCUMENTS as we have demanded, asked and pleaded before but we have only received SILENCE from the OHCHR an Agency that is suppose to protect Political Refugees worldwide and preserve life and dignity and make sure that NO STATE OR COUNTRY VIOLATES THE BASIC HUMAN RIGHTS LAWS ESPECIALLY THE UNITED STATES OF AMERICA AND CANADA.

We also demand that the OHCHR and the UNITED NATIONS take all Legal Actions against the Obama Administration and against the United States of America to PROTECT THE RIGHTS OF ALL LEGAL POLITICAL REFUGEES and ALL LEGAL IMMIGRANTS.

We are demanding that the OHCHR and the UNITED NATIONS NO LONGER IGNORE our demands for EMERGENCY HELP but IMMEDIATELY ACT NOW WITHOUT ANY DELAY AND GET US IMMEDIATELY OUT OF THE UNITED STATES OF AMERICA!

I, Anthony Martini was persecuted, tortured and had numerous murder attempts on my life for over 25 years in Canada. For eight years and three months I had the most inhumane, degrading human rights abuse caused by the United States of America and all its corrupt United States Government Agencies which makes it a

total of thirty-three years of gross human rights abuse by two Countries which is Canada and United States of America.

I, Anthony Martini need to find freedom and peace in a new Country before I die! I have two brain tumors and time is ticking! I will no longer accept silence by the two major Agencies that is supposed to protect Human Life and Human Dignity!

I, Annette Martini had all my human rights violated and persecuted by Canada since I married my husband Anthony Martini.
