Dear Jury Commissioner,

On Thursday, May 13, 2010 I received the attached "JURY SUMMONS" and I was totally SHOCKED and FURIOUS.

I immediately contacted the Phone Number that was attached on the "JURY SUMMONS" and I was told that the Jury Commissioner obtained my name and my address from the D.M.V. – California Department of Motor Vehicles.

The reason why I am so Furious is because I know for a Fact that the "FREEMASONS" in the State of California made sure that my name was given to your Department to get myself Anthony Martini in trouble or arrested.

I know for a fact that the Jury Commissioner did NOT obtain my name from the DMV for the following reasons.

First of all I am NOT an American Citizen and my California Driver's License is FLAGGED.

I am NOT permitted to Vote in the United States of America whether it is City, State, County or in any Federal Elections because I am NOT an American and I do NOT have any status here in the United States of America.

In Order for myself Anthony Martini to legally obtain my California Drivers License I had to supply my E.A.D. – Employment Authorization Card that is issued by the U.S. Homeland Security to the California D.M.V.

My California Driver’s License is ONLY for one year at a time providing that I have a Valid E.A.D. Card that is issued by the U.S. Homeland Security.

Therefore, my Driver’s License is FLAGGED and the Jury Commissioner should have known this.

Furthermore, my California Driver’s License is ONLY Valid for one year at a time and again your Department should have known this and my Driver’s License works with the E.A.D. Card that is issued by the U.S. Homeland Security.

In July 2002 myself and my wife LEGALLY entered the United States of America with Permission from the President of the United States of America, the White House, the U.S. State Department, the U.S. Attorney General and the U.S. Department of Justice as POLITICAL REFUGEES or POLITICAL ASYLEES.

Since July 2002, myself Anthony Martini and my wife Annette Martini have been Politically Persecuted and Politically Tortured by the FREEMASONS here in the United States.

Since, we moved from the State of Florida to the State of California in 2006 we have been placed in False Removal Proceedings by the Freemasons at the U.S. Immigration and the U.S. Homeland Security and myself and my wife have been Persecuted every day.
